

# The Government's Vision

- While significant progress has been made, there needs to be a new joint approach across foundation years services if the full benefits are to be realised and all children will benefit from the programmes and support in place.

# Young children deserve the best provision...

- A coherent approach to promoting child development will provide the best basis for the next stage of learning. The Government will:
  - increase the health visitor workforce by 4,200 by 2015;
  - introduce a reformed Early Years Foundation Stage by 2012;
  - maintain universal free early education for 3&4 year olds, and extend this free early education to all disadvantaged 2 year olds, by 2013;
  - revise the Code of Practice on free early education to reduce national prescription and enable more children to access their full entitlement;
  - strengthen the quality criteria for providers of the free entitlement; and
  - promote a diverse early education and childcare sector.



# Simplifying the EYFS

- Responding to the findings of Dame Clare Tickell's review we have consulted on a revised EYFS:
  - a stronger emphasis on interacting with children and encouraging parents to become involved in their child's development;
  - a focus on early identification of children's additional needs through a mandatory summary of progress at age 2 to 3;
  - a strong focus on basic social, emotional, communication and language skills;
  - a reduction in the number of early learning goals from 69 to 17; and,
  - clearer requirements on providers to help keep children safe (renaming the requirements 'safeguarding and welfare requirements') through a focus on safeguarding training, staff supervision and policies about mobile phones and cameras.
- We sought views specifically on the assessment of children with SEN.
- Consultation closed end September and we received over 2,300 responses which we are now analysing.



# Extending and strengthening the free entitlement

- From Sept 2013 will be extended to the 20% most disadvantaged two year olds - approximately 140,000 children nationally. About to consult on:
  - Eligibility: mirroring free school meals, and looked after children
  - LAs to have flexibility to fund other groups depending on local need (e.g. emerging SEND)
- Will also consult on a basket of eligibility criteria for receiving funding for the free entitlement, for example:
  - the Ofsted inspection rating;
  - internal local authority quality assurance systems;
  - workforce qualifications.



# Mothers and fathers are most important

- Warm and authoritative parenting is critical to children's social, emotional and intellectual development. Strong relationships also make a big difference. So the Government will:
  - introduce new arrangements for more flexible family leave;
  - make sure parents can access relationship support if they need it;
  - support provision of online and helpline family and relationship support;
  - Trialling universal access to parenting classes in 3 or 4 areas;
  - explore ways to enable parents and communities to have more say in the running of Sure Start Children's Centres; and
  - make sure those families who need it the most get extra support with the costs of childcare.



# Children's Centre Governance

- Commitment to put communities at the centre of decision making and to devolve power to the lowest possible level.
- Encouraging Local Authorities to promote diversity of Children's Centre provision: more use of third sector organisations, mutuals and social enterprises.
- Will consult on proposals that will enable parents and community groups to apply to their local authority to run a children's centre in their local area. Local authorities, not the Government, would have the final say on whether projects go ahead



# Early intervention is the key to reducing problems later

- We want to make the most of all opportunities for early intervention in the foundation years by:
  - helping professionals to use all interactions with families as opportunities to identify additional needs and offer further help;
  - Introducing a new requirement on providers to give parents a short written summary of their child's progress around age two and how this could be integrated with the health visitor led development review;
  - encouraging evidence-based parenting programme, and doubling the number of families benefiting from the Family Nurse Partnership; and
  - setting out a new core purpose for Sure Start Children's Centres.



# Children's Centre core purpose

The Government believes that children's centres should have a clear **core purpose**, focused on:

- Improving outcomes for young children and their families, with a particular focus on the most disadvantaged families, in order to reduce inequalities in:
  - child development and school readiness;

Supported by improved:

- parenting aspirations, self esteem and parenting skills;
- child and family health and life chances.

The Government has worked with sector leaders to consider what children's centres can do to achieve the core purpose, including:

- Assessing need across the local community;
- Providing access to universal early years services in the local area including high quality and affordable early years education and childcare;
- Providing access to targeted evidence based, family-centred support;
- Acting as a hub for the local community, building social capital and cohesion;
- Sharing expertise with other early years settings to improve quality.



# Payment by results?

- Government wants to increase the autonomy that Sure Start Children's Centres have, but with this comes greater responsibility and accountability
- Payment by results will operate at two levels: national to local and local to national. A range of measures are likely to be trialled:
  - Early Years Foundation Stage Profile assessments – to narrow the gap in attainment at age five so more children start school achieving the expected level.
  - Breastfeeding prevalence at 6-8 weeks – to be developed in partnership with the Department of Health's plan for a Health Premium for public health outcomes.
  - Parenting/home learning environment – for example, completion of evidence based parenting programmes by vulnerable families.
  - Sustained contact with families in greatest need – so that children's centres are targeting families effectively.



# The workforce is crucial...

- Ensuring there is a well qualified and motivated workforce is fundamental to the experience of children and families. The Government will:
  - review how best to strengthen qualifications and career pathways for workers supporting families in the foundation years – Professor Cathy Nutbrown;
  - continue to invest in graduate-level training in early education, childcare and social care;
  - make early years education professionals part of the remit of the new Teaching Agency, and
  - support the sector in developing system leadership, including reviewing the National Professional Qualifications in Integrated Centre Leadership



# Every part of the sector has a role to play and should be held to account

- Government wants to develop a new relationship which puts more power in the hands of professionals with strong systems of accountability.
- Important roles for every part of the sector to work in a more integrated way, with better information sharing and payment by results.
- The Government will:
  - Work to promote better sharing of information;
  - Introduce payment by results for children's centres; and,
  - Continue with co-production



## Continuing co-production...

- Reformed EYFS - consultation closes 30 September
- School and early years funding – consultation closed Tuesday
- Free early education entitlement statutory guidance – consultation autumn 2011
- Children’s centres statutory guidance – consultation autumn 2011
- Qualifications Review – call for evidence this autumn
